 - 2). Topic: Update to the 2008 Master Plan- Process considerations:
 - Use the word community. Community needs to be involved in this, from the beginning.
 - See what the will of the community is first. What are the most pressing chapters?
 - Ask nonprofits to represent their aspect of the town and be part of this process. A survey to be done upfront?
 - David Little – ask for feedback on the process of 2008
 - What does the community want this Master Plan to be? Time capsule or future plan?
 - Frame questions in a manner in which people can say what they like or dislike about something. Be inviting.
 - Planning Board to do hard data work before survey is created?
- Comprehensive versus chapter by chapter. Comprehensive with reordering and priorities by chapter
 - 2008 Master Plan as a template? Yes
 - Notable changes since 2008: Local regulations and State RSA's – updates have been done to PWSF, Subdivision regulations, Groundwater Protection Ordinance. We now have an inspector.
 - Data collection and analysis: The role of the Build Out Analysis. May work session to review. June- presentable Buildout Analysis for a basis to make further decisions on next phases.
 - Documenting areas already implemented, not implemented or in progress. (See summary of 2019 PB work sessions). Has value
 - Community Involvement.

- Leadership and structure. – what is the ask? Reach out to find representative of the community as a whole. Speak to past writers of the Master Plan.
