**PROOF OF RESIDENCY-one** or more of the following will be required:

Signed Lease/Rental Agreement or Notarized statement from Property Owner listing the property address and registrant's name stating tenancy/residency

Current real estate tax bill stating the registrant's name

Closing paperwork from title company stating the property address and registrant's name as Owner

**MOTOR VEHICLE REGISTRATIONS/TITLE**

**NEWLY ACQUIRED** vehicle purchased from **NH DEALER:**

Certificate of Title Application, and

Bill of Sale, and

Current vehicle registration, if transferring current plates

**NEWLY ACQUIRED** vehicle purchased **OUT OF STATE:**

Certificate of Origin or properly endorsed Title, and

Bill of Sale, and

Current vehicle registration, if transferring current plates, and

All owners present to sign NH Certificate of Title Application

**NEWLY ACQUIRED** vehicle **-MODEL YEAR 1999 OR OLDER:**

Bill of sale and ONE of the following:

Current or expired NH registration in seller's name, or

A valid NH or out-of-state title, or

A completed TDMV-19A (NH VIN Verification Form), and

Current vehicle registration, if transferring current plates

**\*\*\*\*\* PHOTO ID REQUIRED FOR ALL MOTOR VEHICLE TRANSACTIONS\*\*\*\*\***

VEHICLE WITH **OUT-OF-STATE** REGISTRATION for **OWNER(s)** now residing in **TAMWORTH**

**All vehicles 2000 model year or newer require a NH Title to receive a NH Registration**

Vehicle **2000 model year or newer** **NOT FINANCED** require:

Current Original Title or Certificate of Origin, Bill of Sale, and Current Out-of-State Registration

Vehicle **2000 model year or newer** **FINANCED** require:

Current registration and Lienholder/Finance Company/Lessor name and address, and Seller information, to apply for a NH title and to acquire a NH registration.

***To complete Title and registration in our office, all owners listed on Original Title NEED to be present to sign NH Certificate of Title application.***

Vehicle 1999 or older-

Current Out-of-State Registration and **ONE** of the following:

Previously issued or expired NH registration, or

A valid NH or Out-of-State Title, or

A NH TDMV-19A (VIN Verification Form) completed by a NH Law Enforcement Agent or NH Inspection Station or NH Auto Dealership.
